

## FORENSIC

In recent years, and still increasing, companies are facing **conflict situations due to several factors**, including: increased litigation, an increasing regulatory pressure, a higher regulatory activity, arbitrage and new methods of conflict resolutions, the increase in the number of fraud, the economic volume and complexity, as well as a considerable increase of the responsibilities to be assumed, and a considerable increase in responsibilities that the managers must assume presented in such situations. ## VERIFICATION OF NON-FINANCIAL INFORMATION STATEMENTS

Disclosure of non-financial information facilitates **measurement, monitoring and management of companies' performance and their impact on society**. In this respect, it is essential for managing the transition toward a **sustainable global economy** that combines long-term profitability with **social justice** and **environmental protection**. In this context, to improve the consistency and comparability of the non-financial information disclosed, some companies are required to submit a Statement of Non-Financial Information containing information concerning, at least, environmental and social issues, personnel, respect for human rights, and anti-corruption and anti-bribery policies. With the enactment of Law 11/2018 of 28 December and as a result of the implementation of European Directive 2014/95/EU, the companies to which this legislation applies must include a description of the performance policies and the risks associated with these issues in the company's Directors' Report or, if applicable, in a separate report corresponding to the same financial year, which includes the same content and meets the necessary requirements.

Furthermore, with effect from 1 January 2021, the obligation to present the annual statement of non-financial information is extended to all those companies with more than 250 employees that also meet the requirements stipulated in the Law.

**The Statement of Non-Financial Information must be verified by an independent verification services provider.** NEXIA SPAIN Auditoria y Consultoría has the necessary expertise and credentials, applying the same principles of professionalism, ethics, impartiality and independence that characterize all its services.

## PUBLIC SECTOR

Within the public sector, NEXIA SPAIN works with **public entities' internal and external inspection bodies**, advising those bodies whose activity is related to regulatory matters.

### **The services we provide include the following:**

- Collaboration with internal inspection bodies in the review of accounts furnished in support of grants and subsidies and financial auditing of investee organizations.
- Collaboration with external inspection bodies, in financial auditing and verification of legality, financial management audits and verification of grants and subsidies.
